2021-Summer Songdo Dormitory Housing Application Guidance

We would like to inform you of the matters to be aware of when applying Songdo Dormitory due to COVID-19.

- * In order to minimize the risk of COVID-19 infection, you can only apply for 1 person per room. (Reflection of instructions by CDSCHQ.)
- * You must agree to the Attachment's 'Compliance Pledge for Prevention Rules of COVID-19'.
- * If quarantine occurs due to overseas entry, there will be a separate cost. (Please refer to the Attachment's 'Overseas Arrivals Quarantine Guidance'.)
- * COVID-19 test results must be submitted.(For students residing in Korea only)
 - Results of test conducted within 5 days(excluding weekends and holidays) of the check
 -in date(In the case of text results, print out and submit with the student ID number, name, and signature.)
 - Search 'Selection Care Center' on <u>http://ncov.mohw.go.kr</u> and check local 'Selection Care Center'. (Please check in advance as test fee differs for each 'Selection Care Center', and test may not be possible.)
 - Test fees are paid by the individual.
- * While living, you must log in to the 'COVALT app' every day and record without lies.
- * The Songdo Dormitory Regulations are applied the same as in the regular semester.
- * Selection will be conducted within the dormitory acceptance range, and if there are insufficient rooms, the 'selection method' will be announced later.
- * Matters related to joining Songdo Dormitory may change depending on changes in the COVID-19 situation.

- B. New application students
 - 1) Overseas arrivals
 - Immigration certificate(within 1 month of the check-in date or real passport), Chest X-ray results(for tuberculosis test)(within 3 months of the check-in date), Certificate of MMR(Measles, Mumps & Rubella) Vaccination, Compliance Pledge for Prevention Rules of COVID-19

* COVID-19 test will be conducted in quarantine for 2 weeks after check-in.

2) Domestic residents(residing in Korea)

- Immigration certificate(within 1 month of the check-in date), Chest X-ray results(for tuberculosis test)(within 3 months of the check-in date), Certificate of MMR(Measles, Mumps & Rubella)
 Vaccination, Compliance Pledge for Prevention Rules of COVID-19
- COVID-19 test results
 - COVID-19 test results are valid <u>only within 5 days(excluding weekends and holidays)</u> <u>of the check-in date</u>.(In the case of text results, print out and submit with the student ID number, name, and signature.)

6. Information for Move-In

A. Move-in Procedure

- Confirm your identification, Submit documents at each reception when you check in. (ID cards required.)
 - * Only you can enter the dormitory, and parents, family members, etc. cannot enter the dormitory.
- 2) Check your assigned room, get a card key.
- 3) After Check-in, Please submit facility check list on the Songdo dormitory homepage (https://yicdorm.yonsei.ac.kr).
- B. Internal facilities : desk & chair, wardrobes, shoe closet, single bed & mattress,

individual air conditioning & heating system, shower room, toilet, LAN port

C. Required personal items to move-in

- 1) ID card(for the ID confirmation)
- 2) Personal belongings(mattress sheet for a single bed size(1,000*2,000, height 200), bedding, pillow, toiletries, clothes hangers, slippers and etc.)

- * Please make sure to keep the personal belongings in a proper level due to the fact that dormitory is a place for the communal living.
- ★ Size of wardrobes : 280*2,100 for a triple room, 600*2,100 for a double room
- D. All electronic heating devices are not allowed to use in the room. (except for a hair drier or straightener)
- E. No pets are allowed in the dormitory.
- 7. Note
 - A. Room can be re-assigned for the vacation to <u>designated area</u>.(For students currently living at Songdo Dormitory)
 - B. Among 9 weeks applicants, students who are <u>selected to live in 2021-2st should move</u> to the newly assigned room for 2021-2st due to the room inspection and cleaning schedule <u>on the last week of the vacation</u>. Following the further notice, please comply the moving schedule.
 - * 2021-2st housing application is mandatory / Luggage in the room will be kept in the warehouse when you are not in touch during the moving period.(The cost will be charged to the individual.)
 - C. Changing of roommate/room type/period will not be accepted after finishing the payment.
 - D. Housing application will be canceled in case of unpaid.
 - E. Canceling the application for personal circumstances after the payment, please download and fill 'the Refund Application' form from the website (<u>https://yicdorm.yonsei.ac.kr</u> → Community → Form reference) and send it via email to residence@yonsei.ac.kr until 2021. 06. 16.(Wed) 16:00.

* 3 Warning -> Send to 'Regulation Violation Review Committee' and decide expulsion.

- * Caution and Warning is counted integration with 'Songdo Dormitory Regulation Violation'
- * Cumulating the number of violating regulations is applied equally with 'Songdo Dormitory Regulation Violation'
- * Applying a violation of the rules are 'Songdo Dormitory Regulations of COVID-19 Prevention' shall be given priority over 'Songdo Dormitory Regulation'

[Overseas Arrivals Quarantine Guidance]

- **O** To minimize the risk of COVID-19 infection, students entering Korea from overseas will be quarantined in the quarantine building (Building C) for 14 days.
- **O** Only students who are planning to stay for the 2021-Summer can be quarantined, and it is impossible to use the dormitory only for the quarantine.
- 1. Quarantine subject/period: Overseas arrivals / 14 days from the move-in day
- 2. Move-in Period for Quarantine : 2021.06.05.(Sat.) ~ 06.30.(Wed.)
 * Unable to move-in outside this period
- 3. Quarantine Expenses (Residing and supply cost, etc.): 40,000 KRW per day (Meal cost excluded)
- 4. Meal Cost: 5,450 KRW per meal

5. Quarantine Life

- a. Entry : Stay in the room only, no entry outside the room
- b. Meal : Lunch box and bottled water provided 3 times a day* Menu and number of meals cannot be changed
- c. Laundry : Hand-wash in the bathroom
- d. Supplies : 2 tissue rolls, 1 thermometer, 1 ball-point pen, 2 towels, 10 garbage bags (small), toiletries, bedding set

6, Precautions

- a. During the quarantine period, students are required to download Ministry of the Interior and Safety's "Self-Quarantine Safety Protection App" and enter your self-diagnosis record <u>2 times a day</u>.
- b. For those who are <u>unable to eat the provided meals for unavoidable reasons</u>(religion, vegetarianism, food allergy, etc.), and those who <u>can't move-in during the move-in period</u>, <u>must use other outside quarantine facilities</u>, not the dormitory.
- c. Receiving delivery is not allowed during the quarantine period.
- d. Leaving during the quarantine period is not allowed.
